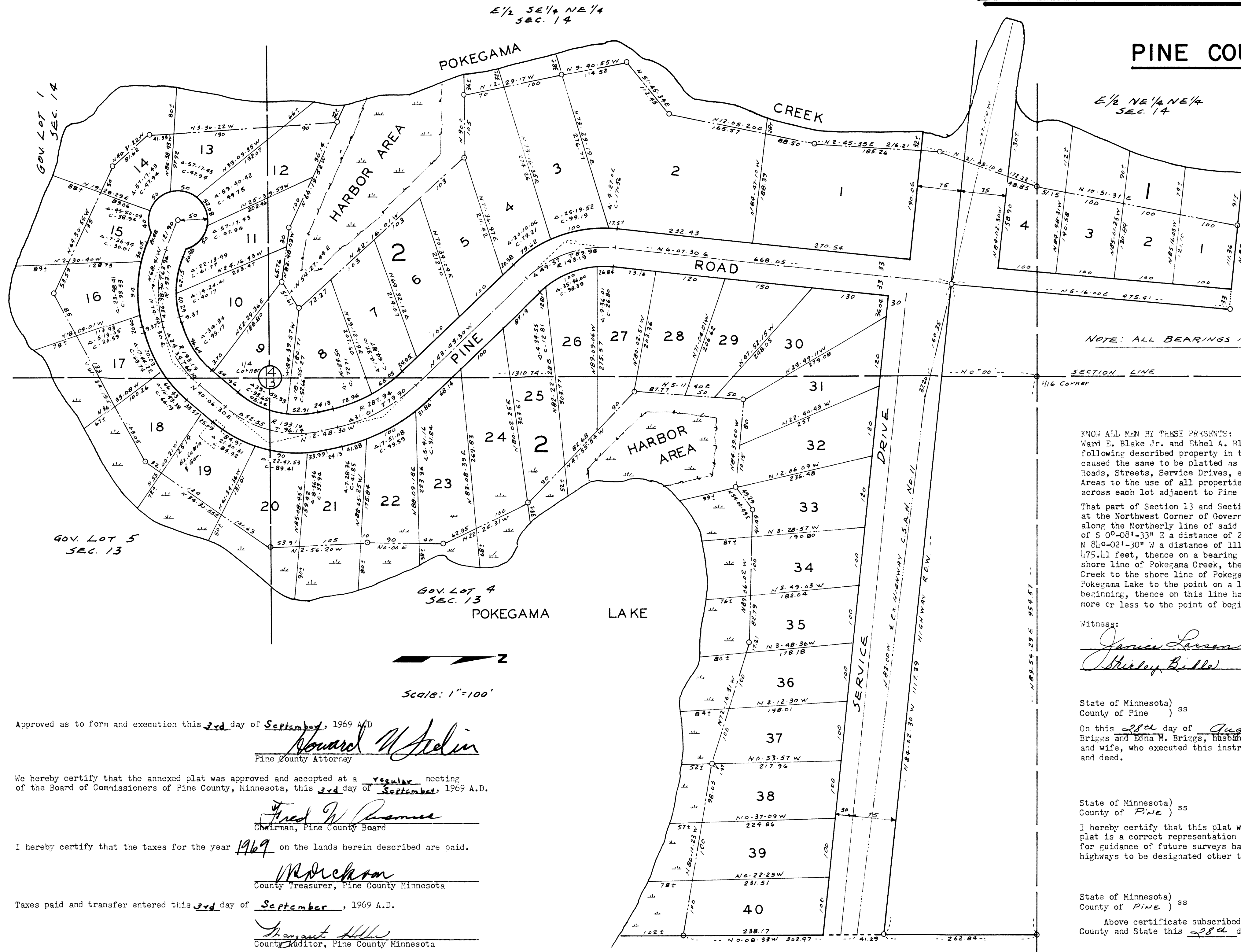


HIGHWOOD SHORES

PINE COUNTY, MINNESOTA

KNOW ALL MEN BY THESE PRESENTS: That Roy R. Briggs and Edna M. Briggs, husband and wife, and Ward E. Blake Jr. and Ethel A. Blake, husband and wife, are the owners and proprietors of the following described property in the Township of Pokegama, Pine County, State of Minnesota: have caused the same to be platted as Highwood Shores, and do hereby donate and dedicate Highways, Roads, Streets, Service Drives, etc. as shown on the plat to the public use forever, the Harbor Areas to the use of all properties adjacent to said Areas, and a ten foot wide utility easement across each lot adjacent to Pine Road and the Service Drive.

That part of Section 13 and Section 14, Township 39, Range 22, described as follows: Commence at the Northwest Corner of Government Lot 4, Section 13, thence on a bearing of N 89° 54' 29" E along the Northerly line of said Government Lot 4 a distance of 954.57 feet, thence on a bearing of S 0° 08' 33" E a distance of 262.84 feet to the point of beginning; thence on a bearing of N 84° 02' 30" W a distance of 1117.39 feet, thence on a bearing of N 50° 16' 00" E a distance of 475.41 feet, thence on a bearing of N 65° 33' 36" W a distance of 235.36 feet more or less to the shore line of Pokegama Creek, thence Southerly and Easterly along the shore line of Pokegama Creek to the shore line of Pokegama Lake, thence Northerly and Easterly along the shore line of Pokegama Lake to the point on a line having a bearing of S 0° 08' 33" E from the point of beginning, thence on this line having a bearing of N 0° 08' 33" W a distance of 445.76 feet more or less to the point of beginning.
