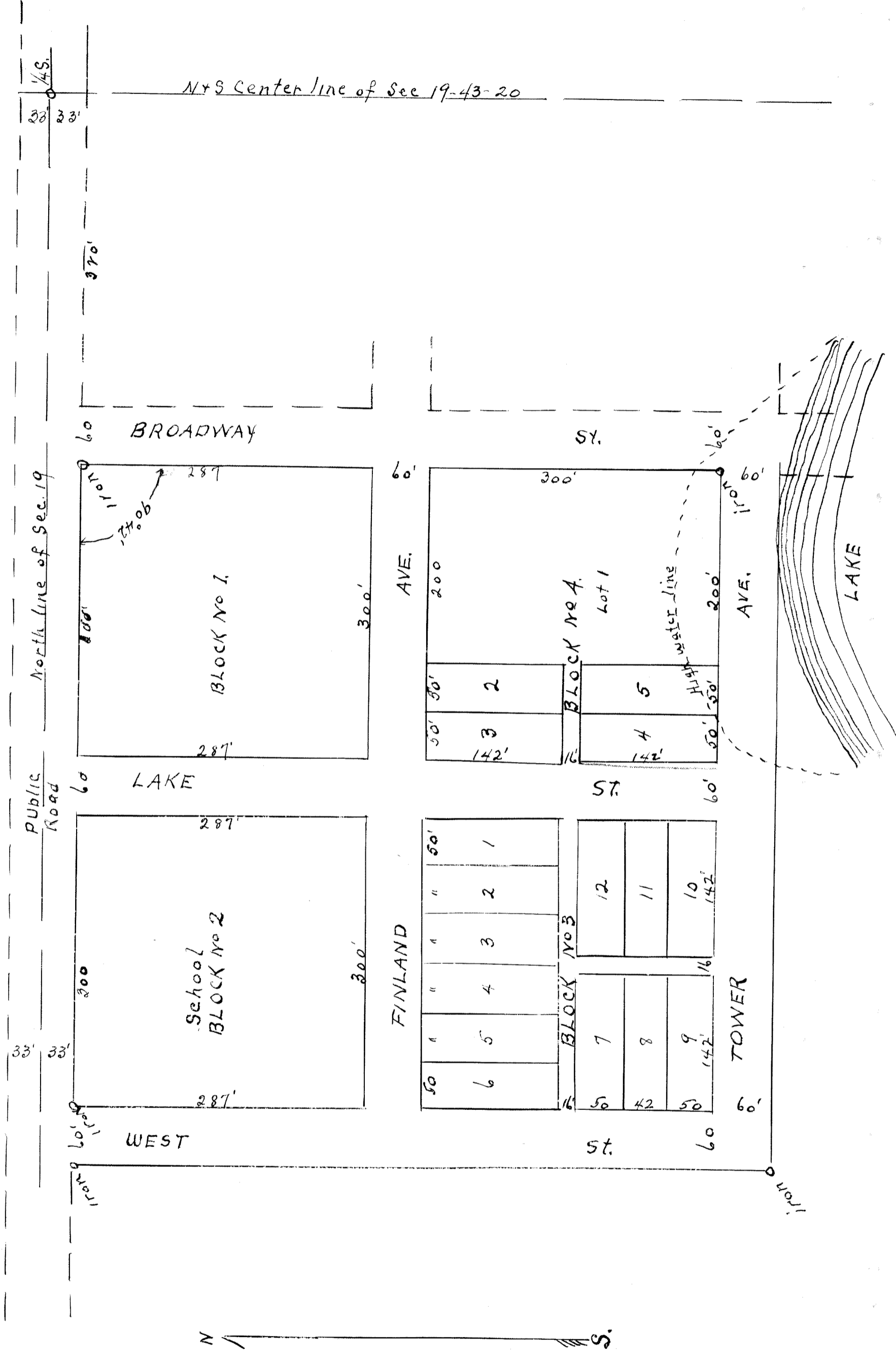


HOGLUND'S 1st ADDITION TO FINLAYSON.
