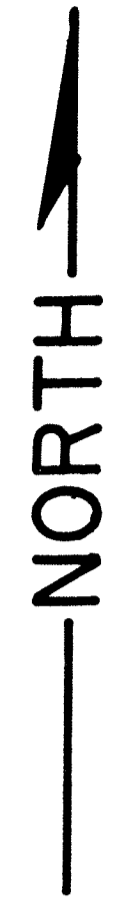
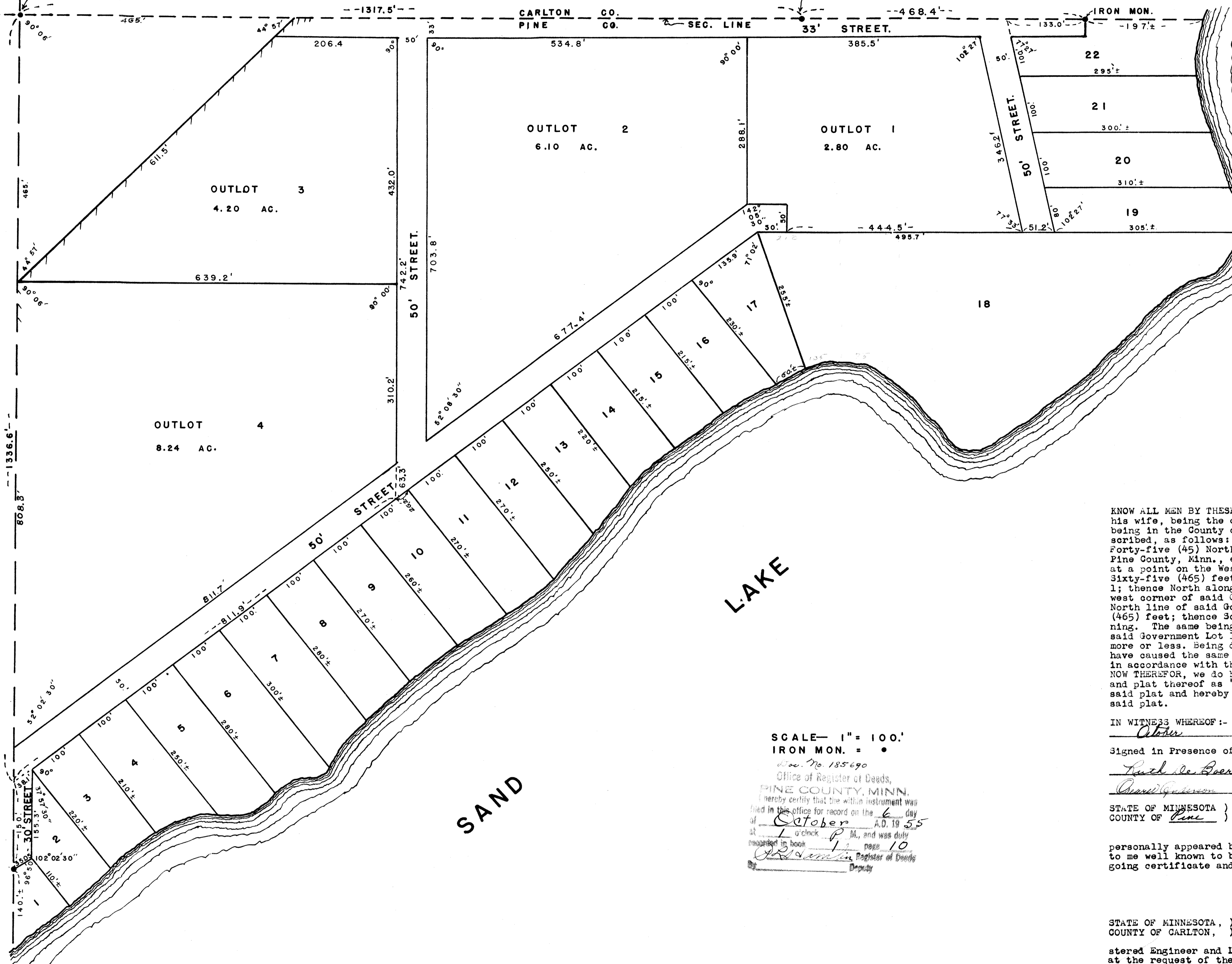

**PLAT DEDICATION**

KNOW ALL MEN BY THESE PRESENTS:- That Vernon L. Perron and Mary E. Perron, his wife, being the owners of the following described property, lying and being in the County of Pine, State of Minnesota, and more particularly described, as follows: Government Lot One (1) of Section Six (6) in Township Forty-five (45) North, Range Nineteen (19) West of 4th Principal Meridian, Pine County, Minn., except that part thereof described as follows: Beginning at a point on the west line of said Government Lot 1, distant Four Hundred Sixty-five (465) feet South of the Northwest corner of said Government Lot 1; thence North along said West line of said Government Lot 1 to the Northwest corner of said Government Lot 1; thence at right angles East along the North line of said Government Lot 1 a distance of Four Hundred Sixty-five (465) feet; thence Southwesterly in a straight line to the point of beginning. The same being a triangular tract of land in the Northwest corner of said Government Lot 1, Section 6, and containing Two and One-half acres, more or less. Being desirous of platting the same into Lots and Streets, have caused the same to be surveyed and the annexed plat thereof to be made in accordance with the statutes in such cases made and provided. NOW THEREFOR, we do hereby ratify and confirm in all respects, said survey and plat thereof as "Perron's Sub-Division", and sign, seal, and execute said plat and hereby dedicate to public use, the streets delineated on above said plat.
