## PINE COUNTY BOARD OF COMMISSIONERS MEETING

# Special Meeting/Rescheduled Regular Meeting

Wednesday, December 7, 2016 - 10:00 a.m.

Chair Curt Rossow called the special meeting/rescheduled regular meeting to order at 10:00 a.m. Present were Commissioners Steve Hallan, Josh Mohr, Steve Chaffee and Matt Ludwig. Also present was County Administrator David Minke. County Attorney Reese Frederickson was absent (excused).

The Pledge of Allegiance was said.

Chair Rossow called for public comment.

Duquette property owners Don and Sharon Smith commented on the public's use of the county-owned gravel pit by their house for ATVing purposes. The Smiths requested the extension of the fence presently in place, and the replacement of the no trespassing signs.

County Veterans Service Officer Ben Wiener acknowledged the 7<sup>th</sup> anniversary of the bombing of Pearl Harbor. Those present observed a moment of silence in recognition.

Chair Rossow requested the following corrections to the Agenda:

# 5. <u>Joint Powers Agreement Between Pine County Sheriff and Attorney and the Bureau of Criminal Apprehension</u>

Approve Resolution 2016-68 approving the Joint Powers Agreement between the Pine County Sheriff and Pine County Attorney with the State of Minnesota, Department of Public Safety, Bureau of Criminal Apprehension for use of the State's Criminal Justice Data Communications Network (CJDN) and authorize Board Chair and County Administrator to sign. The JPA will allow the BCA to provide access to the Minnesota Criminal Justice Data Communication Network. This is a five year renewal.

## 6. 2017 MN Federal Boating Safety Supplemental Equipment Grant

Approve the 2017 Federal Boating Safety Supplemental Equipment Grant in the amount of \$1,912 and authorize Board Chair, County Administrator and County Sheriff to sign. The grant may only be used for safety enforcement equipment purchases. Does not require matching funds.

## 7. Training

- A. Approve County Engineer Mark LeBrun to attend the 72<sup>nd</sup> Annual Minnesota County Engineers Conference at Cragun's Resort in Brainerd, January 17-20, 2017. Total cost: \$842.
- **B.** Approve Team Leader/Senior Probation Agent Laura Stylski to attend Motivational Interviewing Training as an instructor, December 28-29, 2016, and authorize two nights accommodations and mileage reimbursement. Lodging: \$122.08 per night (\$244.16 total); mileage 196 miles at \$.54 per mile (\$105.84). Total cost: \$350.

### **REGULAR AGENDA**

### 1. Retirement of Marlys Mestemacher

The board recognized the retirement of Health & Human Services Social Worker Marlys Mestemacher and thanked her for her 28+ years of service to Pine County.

## 2. Public Health Planning Committee

The Pine County Public Health Planning Committee met November 21, 2016. County Administrator Minke stated in 2017 the Community Health Board will consist of five commissioners and the public health meetings will be part of the county board meeting. Also, as a Community Health Board the county may appoint a representative to the State Community Health Services Advisory Committee (SCHSAC).

#### 3. Facilities Committee

The Facilities Committee met December 7, 2016. County Engineer Mark LeBrun presented an update on space and building planning for Health & Human Services in Sandstone. An updated lease with the City of Hinckley for heated storage was discussed. These items will be addressed at the December 20, 2016 board meeting for consideration.

## 4. Personnel Committee (Special Meeting)

A special meeting of the Personnel Committee was held November 30, 2016. The Committee made the following recommendations:

### Health & Human Services

- A. Eliminate the Family Service Aide position to create a social worker position with a higher level of education and experience to increase service delivery to clients, effective December 14, 2016.
- B. Approve hiring of one Social Worker position focusing on children's services.

# **Land Services Department**

A. Eliminate the single-purpose County Recorder position effective December 14, 2016.

Discussion was held regarding the duties of the positions and the effect to the budget.

County Administrator Minke stated the elimination of positions is due to budgetary constraints and organizational restructuring, stating that current projected balance of the General Fund is a negative \$4,000. With the elimination of these positions, it creates a net balance of \$85,000 in the General Fund, which is closer to the \$100,000 contingency directed by the county board.

The County Recorder duties will remain in the Land Services Department.

**Motion** by Commissioner Chaffee to approve the elimination of the Health & Human Services Family Service Aide and single-purpose County Recorder, effective December 30, 2016.. Second by Commissioner Ludwig. Motion carried 5-0.

No action was taken as to the hiring of a Social Worker. This will be discussed at the December 20, 2016 county board meeting.

# 5. Pine County Soil and Water Conservation District (SWCD) Project on Cathedral Pines Drive

Pine County Soil and Water District Manager Jill Carlier gave a presentation showing the erosion project at Cathedral Pines Drive. Grants were applied for after the 2012 flood. The Minnesota Board of Water and Soil Resources (BWSR) and the Minnesota Department of Natural Resources awarded grants totaling \$540,000, with no match necessary.

## 6. East Central Drug and Violent Offender Task Force Grant Agreement

**Motion** by Commissioner Ludwig to approve the 2017 East Central Drug and Violent Offender Task Force grant in the amount of \$130,000 and authorize Board Chair and County Administrator to sign. Second by Commissioner Chaffee. Motion carried 5-0.

#### 7. State Aid Designation Changes

County Engineer Mark LeBrun stated the Transportation Committee recommended the approval of the transfer of state aid designation of 2.25 miles of CSAH 5 to be placed on County Road 110 and County Road 125 as part of the 2017-2021 transportation plan. LeBrun presented the following resolutions to complete the transaction. In addition, the City of Rock Creek will be required to approve the County Road 110 change.

Second by Commissioner Mohr. Motion carried 5-0.

Chair Rossow recessed the special board meeting/rescheduled regular meeting, and opened the Regional Railroad Authority meeting at 10:49 a.m.

County Administrator Minke provide an overview of the amendment to the Minneapolis-Duluth/Superior Passenger Rail Alliance (NLX) Joint Powers Agreement.

**Motion** by Commissioner Ludwig to approve the Amended Joint Powers Agreement Establishing the Minneapolis-Duluth/Superior Passenger Rail Alliance and authorize Board Chair and County Administrator to sign. Second by Commissioner Chaffee. Motion carried 5-0.

There being no additional Regional Railroad Authority business, Chair Rossow adjourned the Regional Railroad Authority meeting at 10:52 a.m.

The special meeting/rescheduled regular meeting reconvened at 10:52 a.m.

### 8. Commissioner Updates

MLBO Tribal Summit: Commissioners Hallan, Chaffee and Ludwig stated it was a very good meeting and commended county staff for their involvement.

Arrowhead Counties Association: Chair Rossow stated the legislative priorities were set, with the top three priorities being Indian Child Welfare Act, Payment In Lieu of Taxes (PILT), and child protection/allocation.

Northeast Regional Emergency Communications Board: Commissioner Hallan stated a quorum was present and stated the 911 fee on your phone bill is the fee that pays for the 800 MHz radios, dispatch equipment, etc.

Rush Line Task Force: Commissioner Mohr unable to attend meeting.

Lakes & Pines Community Action Council: Chair Rossow stated that \$19,000 Community Service block grant and \$50,000 Central Minnesota Council on Aging grants were awarded. Repairs to the building were discussed.

Snake River Watershed: Commissioner Mohr stated updates were given on projects.

Comprehensive Plan Steering Committee: Commissioner Ludwig unable to attend.

NLX: Burlington Northern Railroad and NLX are going over the models for the trips.

Law Library: Commissioner Mohr stated no quorum present.

Extension Committee: Commissioner Mohr stated this meeting was held at the Audubon Center in Sandstone. Smithsonian Water exhibit on display.

Association of Minnesota Counties Annual Conference: Commissioners stated it was a very good conference.
