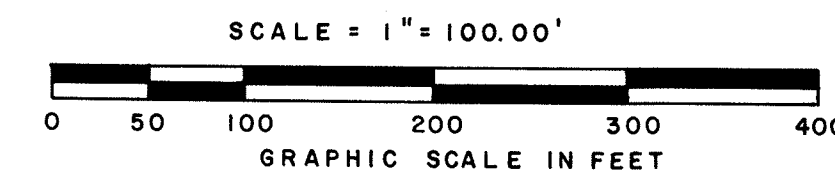
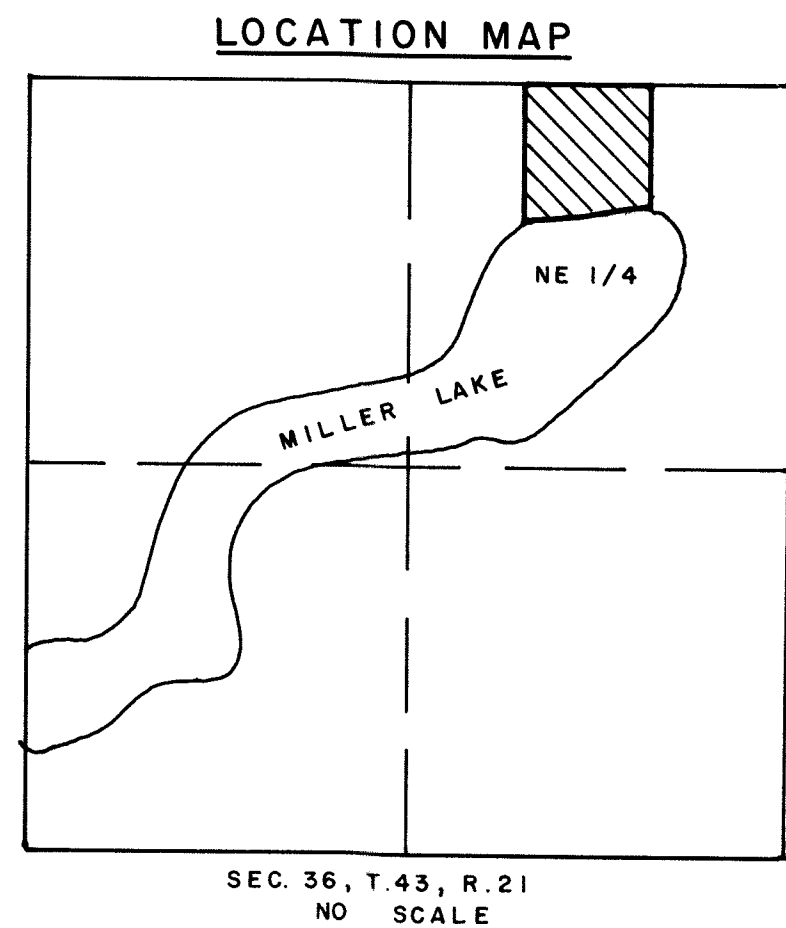
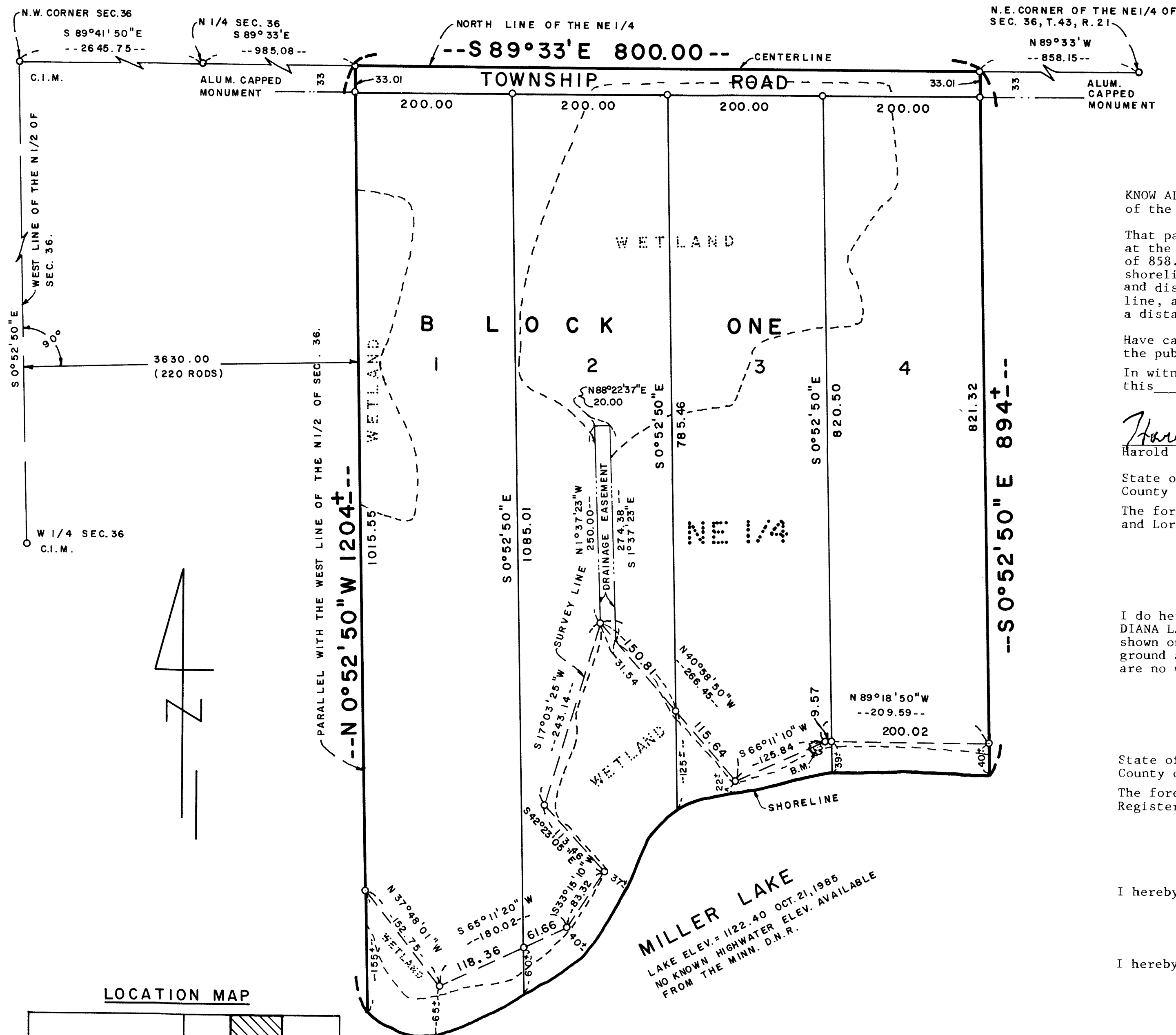


DIANA LANE 2ND ADDITION

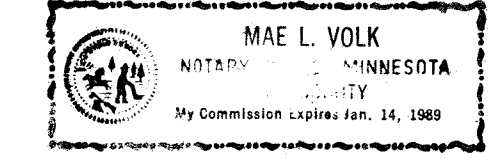

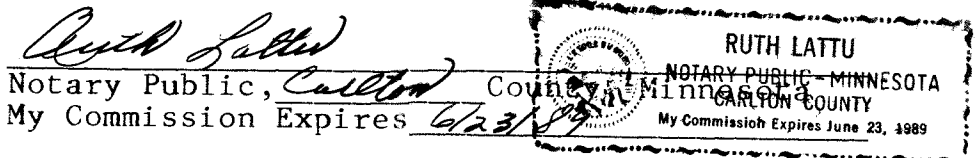
