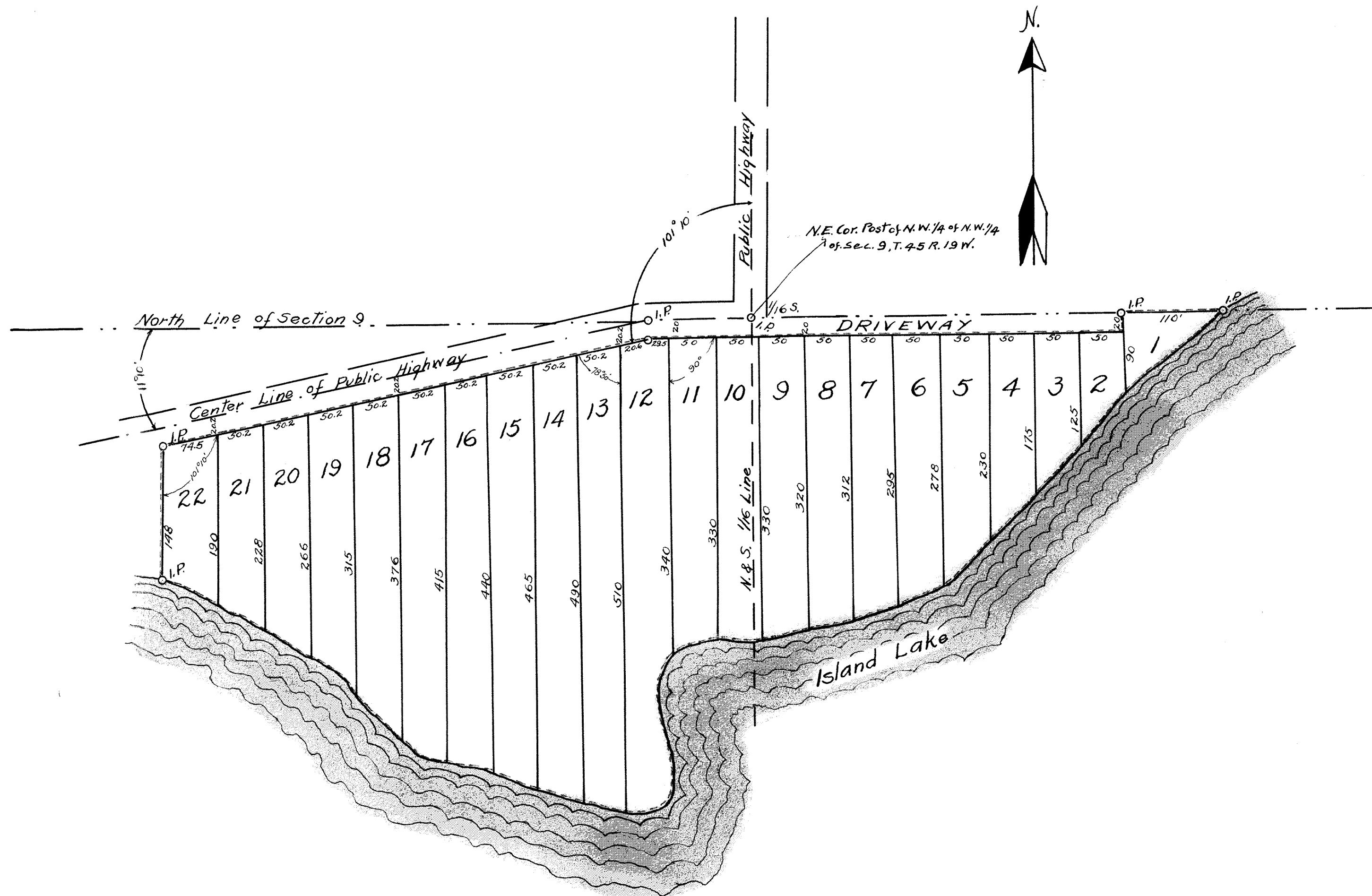


# EKLUND'S BEACH.

KNOW ALL MEN BY THESE PRESENTS: That Swan Eklund, single being the owner of the following described property, lying and being in the County of Pine and State of Minnesota to wit: Commencing at the Northeast corner post of the Northwest quarter of Northwest quarter (NW 1/4 of NW 1/4) of Section Nine (9), Township Forty-five (45), Range Nineteen (19), as a place of beginning, thence in a westerly direction following the public highway a distance of forty (40) rods, thence due south to the North shore of Island Lake, thence in a easterly direction following the north shore of Island Lake to a point of intersection with the north section line of Section Nine (9), thence due west following the north section line of Section Nine (9), to the place of beginning. Above described parcel of land is a part of Lot Eight (8) Section Nine (9) Township Forty-five (45) North Range Nineteen (19) West of the 4th. Principal Meridian, according to the United States Government survey thereof, and being desirous of planting the same into Lots, have caused the same to be surveyed and the annexed plat thereof to be made in accordance with the statutes in such cases made and provided. Now, therefore, do we hereby ratify and confirm in all respects said survey and the plat thereof as "EKLUND'S BEACH," and sign seal, and execute said plat and hereby dedicate to the public, the use of the Road herein delineated and also driveway shown on plat.
