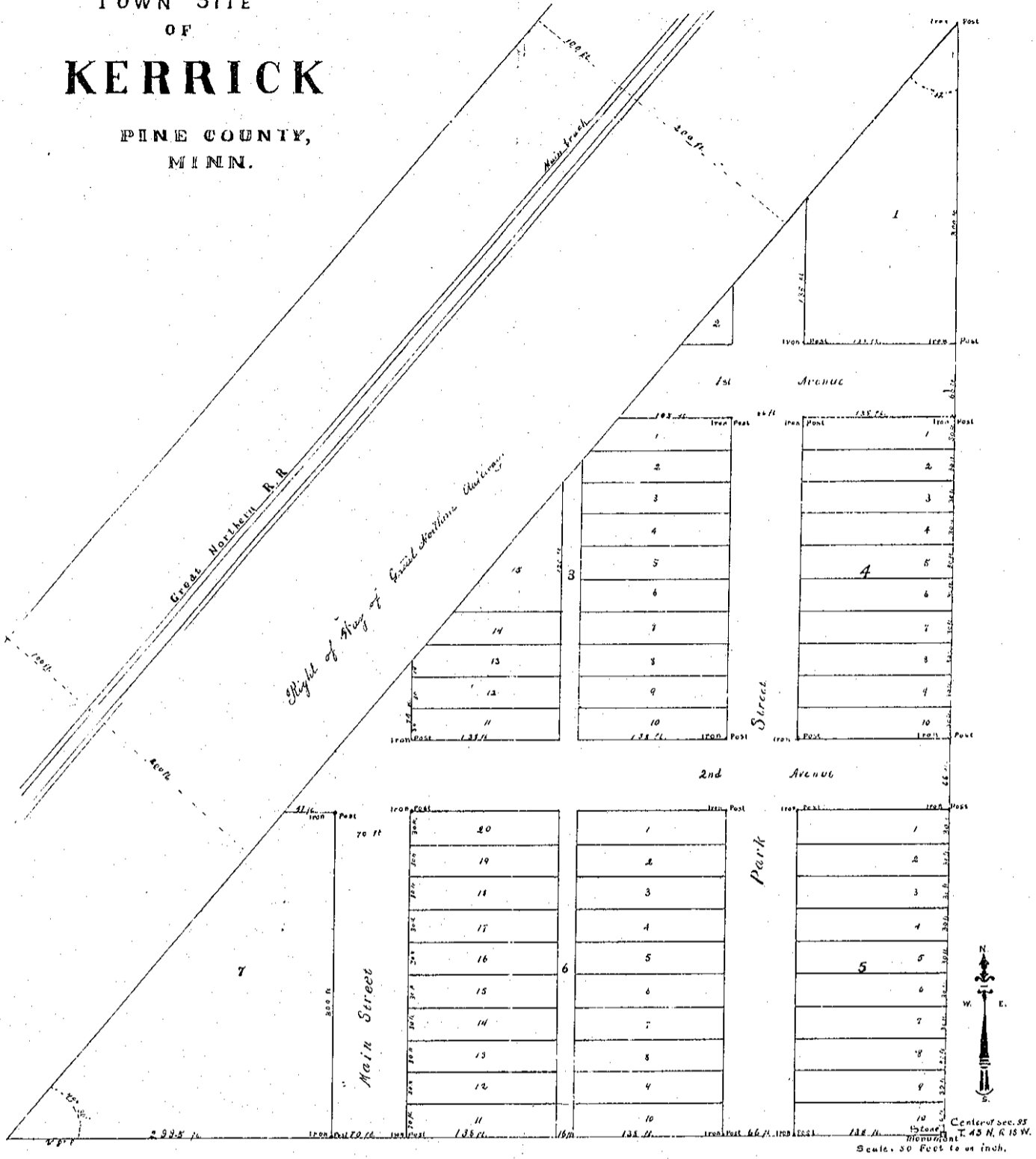


TOWN SITE

Know all men by these presents, that we,

owners and proprietors of the following described premises, viz:  
All that part of the southeast fourth (S.E. 1/4) of the Northwest fourth (N.W. 1/4) of section thirty-five (35), Township Forty-four (44) North, of Range Eighteen (18), West of the Sixth Principal Meridian, lying East of the Right of Way of the Great Northern Railway Company, and being desirous of platting the same as a townsite, have caused the same to be surveyed and platted, and the annexed plat thereof made, according to the statutes in such case made and provided, to be known as the townsite of Kerrick.  
And we hereby dedicate to the public, and for public use forever, all the streets, avenues and alleys, as shown on said plat.
