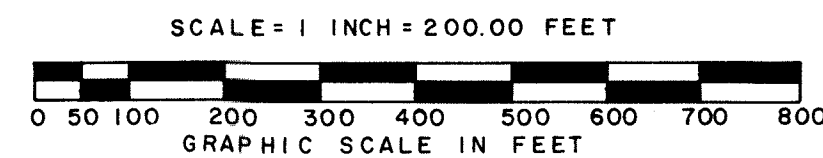
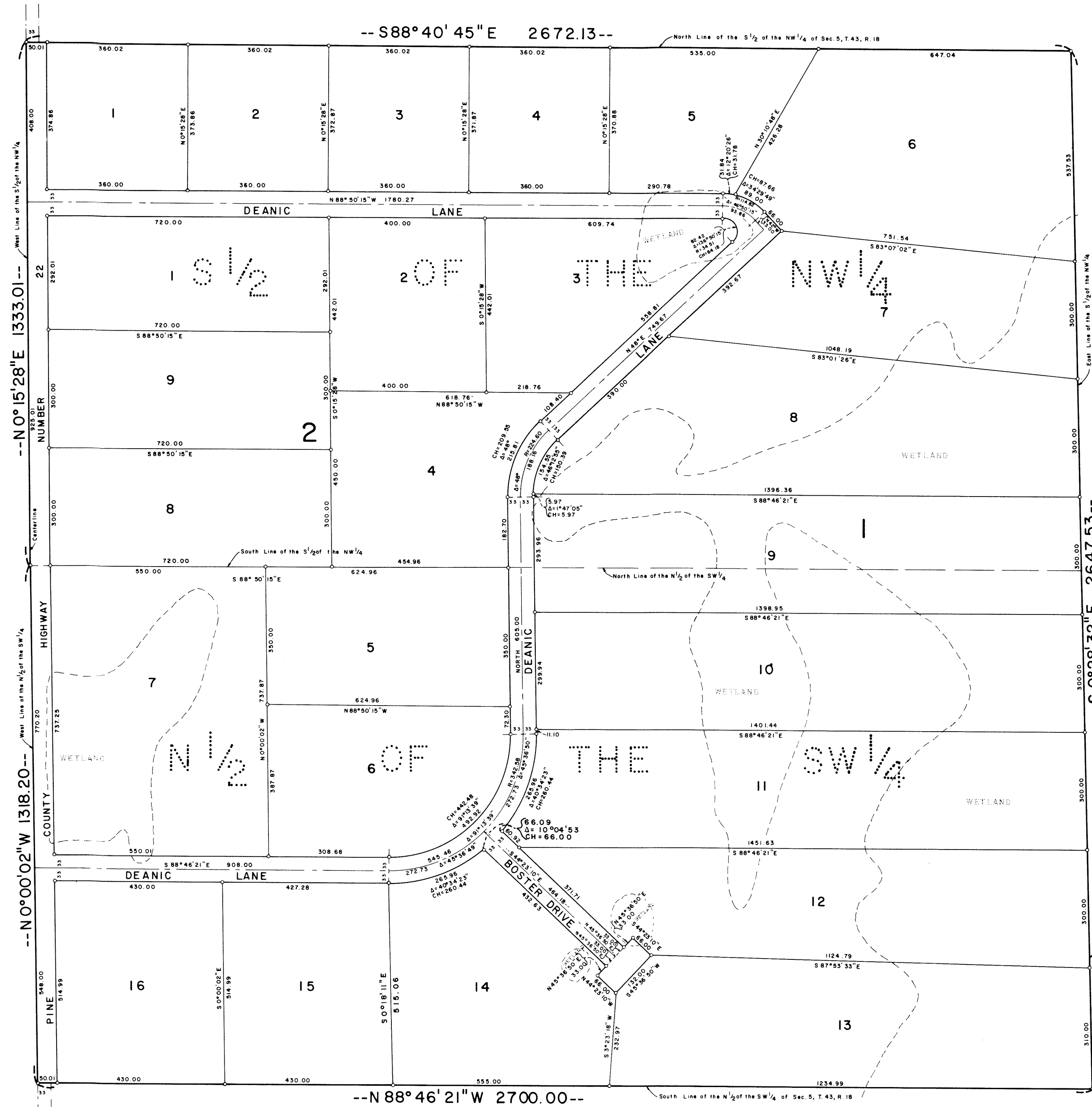
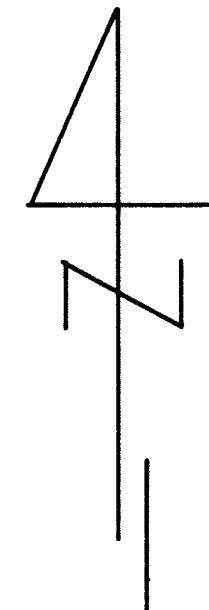


POOTZIE ADDITION

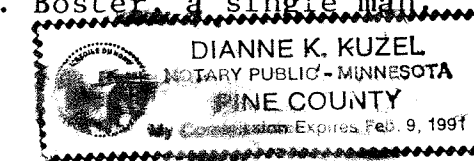

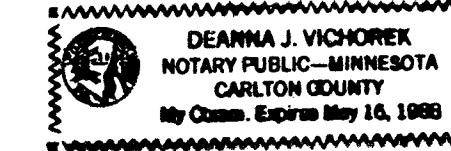
