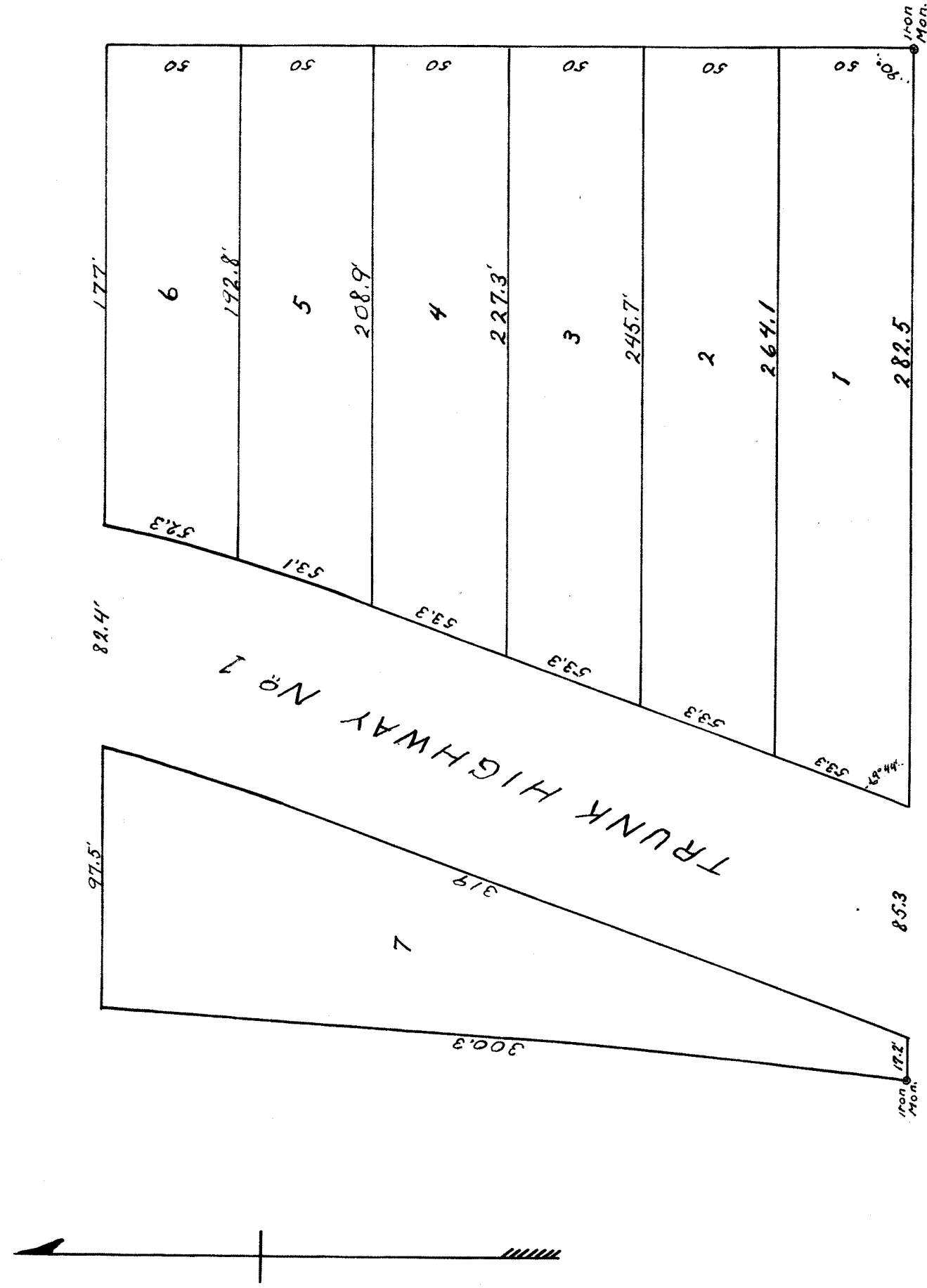


**STANTON'S SUBDIVISION OF LOT 22 OF AUDITOR'S
