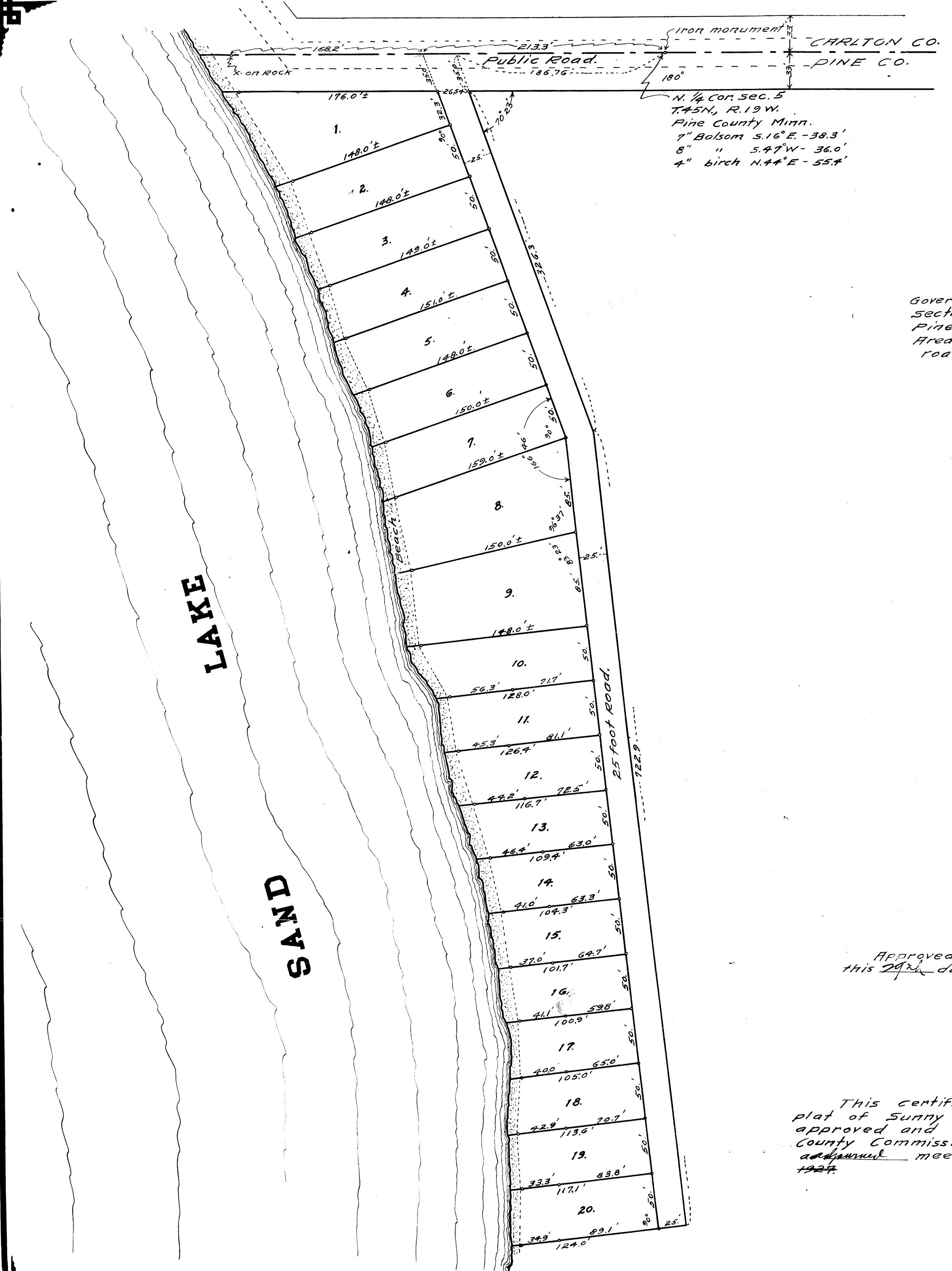
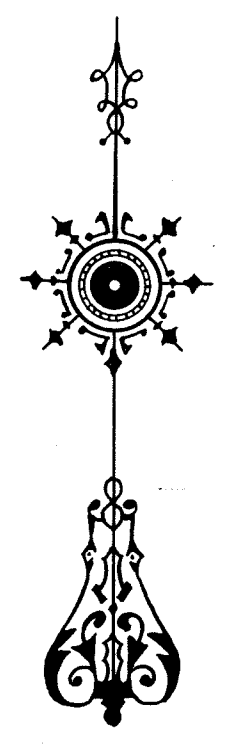


**PLAT**
