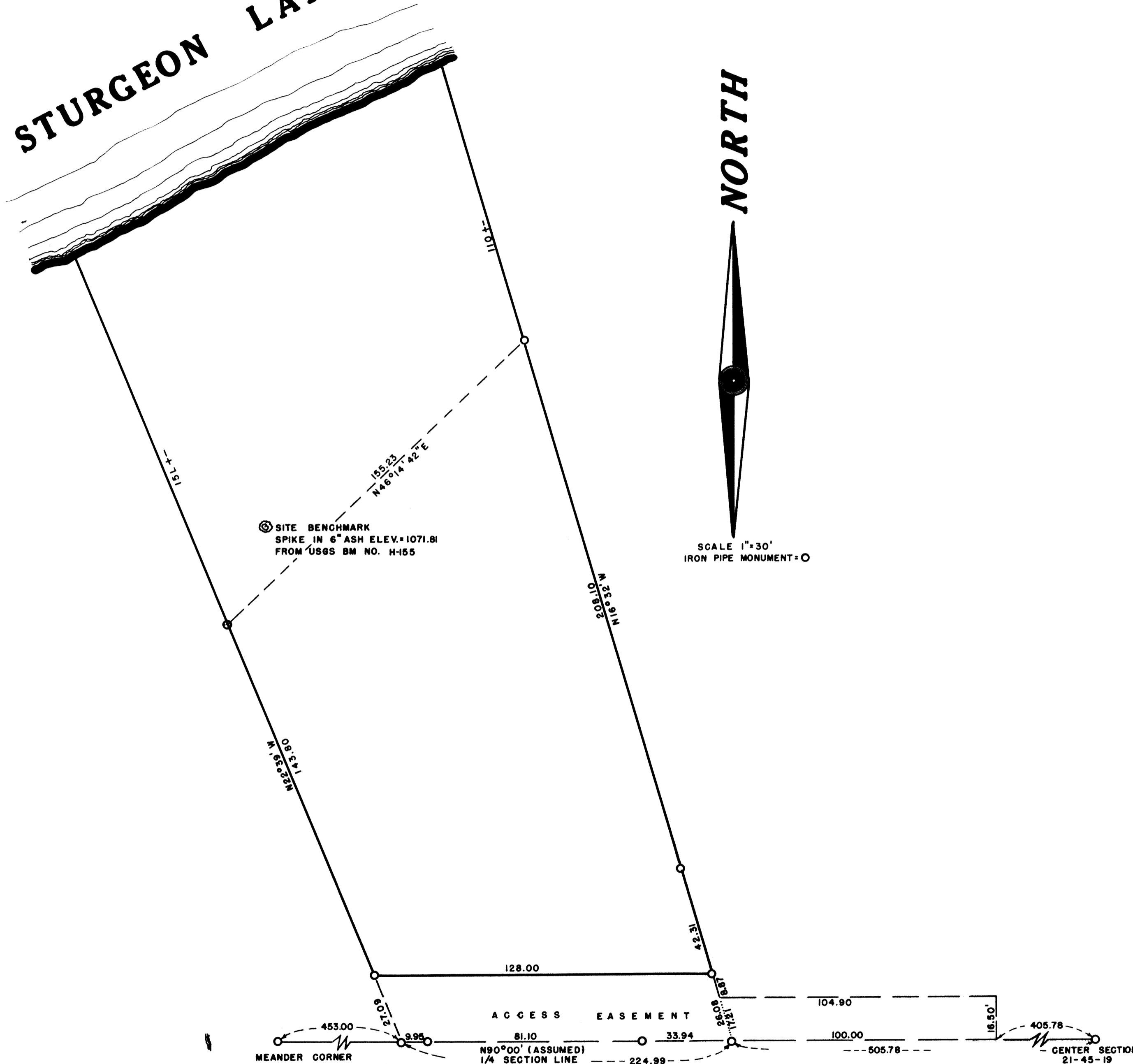


MAXIMUM HIGH WATER AUGUST 19, 1947 ELEV. = 1068.37

KNOW ALL MEN BY THESE PRESENTS:- That Neubert W. Swanson and Gladys E. Swanson, husband and wife, being the owners of the following described property lying and being in Government Lot 3 of Section 21, Township 45 North, Range 19 West of the 4th Principal Meridian, Pine County, Minnesota, more particularly described as follows, to wit: Commencing at an Iron Monument at the center of said Section 21, thence bearing North 90° West on the Quarter Section line a distance of 505.78', thence bearing North 16° 32' West a distance of 26.08' to the point of beginning of the tract to be herein described, thence bearing North 90° West a distance of 128.00', thence bearing North 22° 39' West a distance of 295', more or less, to the shore of Sturgeon Lake, thence in an Easterly direction on said shore line a distance of 150', more or less, to a point which bears North 16° 32' West from the point of beginning, thence bearing South 16° 32' East a distance of 360', more or less, to the point of beginning. Containing 1.06 Acres, more or less.
