PLAT DEDICATION

KNOW ALL MEN BY THESE PRESENTS: That Sturgeon Lake Industries, a Minnesota Corporation, being the owners of the following described property lying and being in Section 20-Township 45 North-Range 19 west of the 4th Principal Meridian, Pine County, Minnesota and more particularly described as follows, to-wit: Beginning at the North West Corner of said Section 20 thence South on the Section line 500.0', thence at right angles East a distance of 645.33', more or less, to the shore of Sturgeon Lake, thence Northerly on said shore line a distance of 499', more or less, to a point which is 32' South, measured at right angles, of the North line of said Section 20, thence East parallel to the North line of said Section 20 a distance of 261.79', more or less, to the East Right of Way line of Public Road, thence deflecting to the right an angle of 80° 02' 30" a distance of 33.51' to the North line of said Section 20, thence West to the point of beginning, Containing 4.77 Acres all in Government Lot No. 1, being desirous of platting the same into lots and blocks have caused the same to be surveyed and the annexed plat thereof to be made in accordance with the statutes in such cases made and provided. 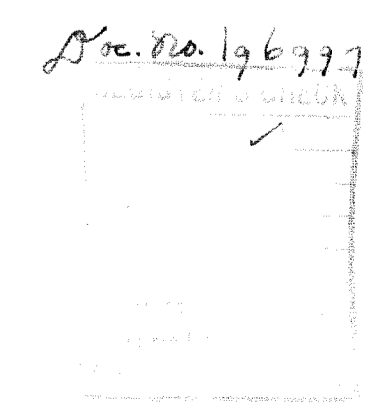
